

**Minutes of Ampleforth Parish Council Meeting held in the Village Hall  
on Thursday 5th April 2012 at 7.30pm**

**Present:** Councillors M Raynar (Chairman), T Pite, and C Smith.

**1. Apologies for absence**

Apologies for absence were received from Councillors Lane and Toynbee.

**2. Declarations of interest**

Councillor Raynar declared a prejudicial interest in the planning application No: NYM/2012/0167/FL as she is a relative of the applicant.

**3. Minutes**

The minutes of the Ordinary Meeting on March 1<sup>st</sup> 2012 and of the Additional Ordinary Meeting (Planning & Trees) on March 8<sup>th</sup> 2012 were agreed and signed.

**5. Reports**

**a) Chairman's Report.**

The chairman reported that there had been inquiries about the work by the parish council to the tree by the phone box, the vacant Common Share, the Fish and Chip Shop planning and parking, parking near the bend at the bottom of the hill at the east end of the village, the recycling of cardboard and plastic by RDC. She read out a letter of thanks from Father Bonaventure for the grant for work in St Benedict's Churchyard.

**b) Broadband Champion's Report**

Ms Sue Shepherd gave a verbal update on the current position and the group's plans to put in a proposal by the deadline of the 1 June 2012.

**6. Planning**

**a) The council considered the following planning applications.**

**Application No: 12/00157/FUL**

**Proposal:** Installation of tubular solar collectors on 2 no. south/south west facing roof slopes of the cricket pavilion to heat water for showers and sinks

**Location:** Ampleforth Abbey And College Ampleforth Helmsley YO62 4EN

**Applicant:** Ampleforth Abbey & College (Miss Sophie Norris)

**Decision: Support.** The council commented that such applications should be encouraged for their environmental benefits.

**Application No: NYM/2012/0167/FL**

**Proposal:** Material minor amendment to planning approval NYM2007/0338/FL (allowed on appeal) to allow an increase in size of footprint and alterations to the design of the lodges together with the erection of timber plan room. **Location:** Studford Farm, High Street, Sproxton.

**Applicant:** Mr R Fawcett, The White Swan, Ampleforth.

**Decision:** The council could not decide on this application as one of the 3 members present had declared a prejudicial interest leaving the council inquorate. It was **deferred** for a meeting to be arranged.

**b) The council noted the outcomes of the following applications.**

**Application No: 11/00621/CON.**

**Proposal:** Demolition of an agricultural building. **Location:** East End Garage, Main Street, Ampleforth. Gem Construction & Shopfitting Ltd.

**Decision: Approved**

## 7. DeFRA Consultation on National Parks Governance

The council responded to the consultation and agreed with the following proposed changes to:

- make it possible for National Park authorities to include some directly elected members,
- remove the need for the Secretary of State to appoint the parish members,
- make it possible to allow parishes in subsequently specified National Parks to choose non-councillors for their seats,
- apply a maximum length of service of 8 years.

The council opposed the following change to relax the political balance requirement on local authorities when appointing their members to a National Park Authority.

## 8. Finance

- a) The grant application was withdrawn as the Jubilee Committee will submit one on their own behalf in due course.
- b) The council received a financial statement (Bank Reconciliation and Budget Monitoring).
- c) The council agreed the following payments to a total of £1889.26 and agreed that the cheques would be signed following the meeting as there was only one signatory present.
