The council resolved to agree and sign the minutes of the Meeting held on the 4 July 2013.

Councillors reported that streetlights were out on West End, opposite the White Horse and overnight camping by a campervan in the village.

# 6. Planning

- a) The council considered the following applications.

**Proposal** Non material amendment to planning approval NYM/2010/0858/FL to allow the installation of windows in place of doors and alterations to the design of the central door to the side elevation. **Location** Prospect House, Ampleforth.

iii) Application No 12/00586/FUL (amended earlier application)

**Applicant** Ampleforth Abbey & College

Proposal Erection of a four bedroom dwelling with detached double garage

**Location** Land to the rear of Martlet House, Back Lane, Ampleforth – amended earlier app.

**Decision: No objection** 

# 7. NYCC Bus Service Consultation

After a discussion this item was deferred until the November meeting.

# 8. Streetlights

- a) The council agreed to the estimate of £1,500 from NYCC for replacing the streetlight on track between Back Lane & East End.
- b) This item was withdrawn as Ampleforth College have removed the streetlights.
- c) The council noted that NYCC have completed their work on the Ampleforth Parish Council streetlights on Station Road and St Hilda's Walk and that adoption by NYCC is underway.

# 9. Cemetery and Churchyard – Trees and Fees and Memorials check

- **a)** The council noted that no objection was received for the application to RDC by the council to undertake work on the churchyard trees.
- **b)** The council agreed the cost of the work to the large ash tree, £275. Mr Young will leave firewood stacked and in manageable pieces by the entrance gate and will clear away the rest.
- c) The council agreed that as long as the new quotation for the remaining work to the trees in the churchyard was not too different from the previous quotation, the work can go ahead.
- d) The council resolved to introduce an Exclusive Right of Burial Fee of £75 for 60 years.
- e) The council resolved to reduce the fees for memorials to £117 for memorials and £62 for a cremation stone/tablet.
- **f)** Councillors Pite, Smith and Raynar agreed to undertake an annual safety check of memorials in the churchyard and cemetery with the clerk.

#### 10. Litter signs

The choice of locations for litter signs was delegated to councillors Smith and Pite.

# 11. Planning and s106 agreements

The council received the agreement for the East End Garage site.

#### 12. External Audit/Annual Return

- **a)** The council noted that copies of the Notice of conclusion of Audit and right to inspect the Annual Return have been posted on the noticeboard.
- b) The council noted that the External Auditor has issued their certificate and opinion, and stated that the audit of the annual return for the year ended 31 March 2013 was complete, and that "on the basis of our review, in our opinion, the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met."
- **c)** The council noted the comment under the heading "other matters not affecting our opinion which we draw to the attention of the council", that 'The Council did not provide an explanation for the variance between the prior and current year values in Box 6 of Section 1".<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> Box 6 which was not completed on the Variance Form was 'All other payments' which increased from £13,314 to £15,906, an increase of 19.5%, £2,592. (Parish Poll £1,818 and work on Millennium Green Path £950, total £2,768)

# 13. Finance and Councillors' Audit and Governance

- a) The council resolved to publish draft minutes on its website.
- **b)** The council noted that under the National Agreement, a 1% pay increase has been awarded to the clerk, back-dated to 1 April 2013.
- c) The council resolved to ratify the issuing of replacement cheques to Alec Thrower as those posted to him after the July meeting went astray in the post.
- **d)** The council resolved to ratify the payment by cheque of R Wedgwood on the 11<sup>th</sup> July as his account was received too late for the July meeting, cheque no. 100026, £436.
- **e)** The council resolved not to respond to the RDC Precept Consultation as it was too soon to prepare the parish council's budget.
- f) Councillors' Audit for July and August was arranged for September.
- g) The council received a bank reconciliation and a budget update to 31 July 2013.
- h) The council agreed the following payments and the cheques were signed.
