Minutes of the Meeting of Ampleforth Parish Council held in the Village Hall on Thursday 6 March 2014 at 7.30pm

Present Councillors Toynbee (chairman), Lane, Pite, Raynar and Smith **Also Present** Three members of the public who had all left by the end of Agenda

Item 8 and V Ellis (clerk)

A member of the public commented before the meeting started about the planning application at Glebe Farm and the possibility of Deceleration Zones on the approaches to West End and East End.

1. Apologies

None.

2. Code of Conduct and the Ethical Framework

There were no declarations under the code of conduct.

3. Minutes

The council resolved that the minutes of the Meeting held on the 6th February 2014 were agreed and signed.

4. Public Participation

Two residents commented on the following matters:

- Planning Application 14/00114/FUL. They were concerned about proximity to a dwelling, use of and noise from the units, the loss of a wood, the access, deliveries and extra traffic on Station Road.
- Station Road development. If there is a noise problem during building from delivery lorries, Ailish Lilley from Environmental Health at RDC can be contacted.

5. Planning . Part a of this agenda item was brought forward.

a) Application No. 14/00114/FUL Applicant Mr John Seeger

Proposal Erection of 6 no. general industrial units with associated parking and alterations to access track to include widening of entrance and formation of passing places

Location Land North Of Sewage Works, Mill Lane, Ampleforth, Helmsley YO62 4EJ **Decision Objection.** The council objects to this application on the following grounds.

- Highway Safety: An increase in the amount of traffic on a narrow rural road and lorries delivering will not be able to enter the site, they will have to park on the road.
- Loss of amenity to neighbours and overlooking a garden at the back.
- Noise.
- Lack of control over what the units will be used for, lack of clarity about what they will be used for, no feasibility study, and no control over when they are accessed and used.
- An unsuitable development within the AONB that will involve the loss of a wood.

The council requests that if these units are approved that good screening is a condition.

6. Broadband Champion's Report by Sue Shepherd. This agenda item was brought forward.

Ms Shepherd gave a verbal update. The Ampleforth/Gilling group met NYnet about the delay in superfast broadband for Ampleforth and had been in touch with County Councillor Clare Wood for assistance and advice. The contract between NYnet and BT allows BT to choose who they will do and when. There is no money for Ampleforth but it is still on the list though not all properties may get it. East End has Fibre to Cabinet 1 so properties in reach of that Cabinet should get Superfast Broadband. Ryedale will now get 78% coverage, not 90%.

7. Playing Field. This agenda item was brought forward.

A discussion was held with Ms Tracy Hutchinson of the Ampleforth Playing Field Committee. She informed the council that the Committee had some new members.

8. Finance and Governance. Part 'a' of this agenda item was brought forward.

The council considered requests from Ampleforth Playing Field Committee. The council resolved to delegate permission to the clerk to pay a grant in March 2014 towards the insurance and the annual play areas inspection on receipt of 2 or 3 quotes from Ms Hutchinson.

The grant is conditional on the annual inspection being completed with 20 working days of the grant being paid and the council receiving a copy of the inspector's report.

9. Exchange of information and items for next agenda. To include Chairman, Champion & Clerk Reports. Part of this item was considered earlier, see Minute 6.

The chairman reported that she had a meeting with a representative of the neighbours adjacent to the Station Road development and one from David Wilson Homes.

- viii. The clerk had authorised urgent work to a tree in the vacant Common Share on Beacon Bank.
