1. Exchange of information

Correspondence Received and Circulated:-

- Complaints received regarding loose dogs and dogs attacked in/around the Millennium Green. Councillor Carter to chase up the installation of the signs. Update: The signs have now been installed.
- Email received from a resident regarding the newly installed dog signs in the Millennium Green and enquiring about a bench being made available on the playing fields that is not in the children's play area. Clerk advised the resident that loose dogs are not permitted in the Millennium Green and that although the PC are not responsible for the playing fields we have asked previously for a bench to be added for the use of dog walkers, away from the children's play area which was agreed by the Playing Fields Association. Clerk to chase.
- Concerns received regarding speeding on the hill into the village. It was reported that a 'children playing' sign was once present in this area. It was requested for the Clerk to speak to NYCC Highways to see if a new sign could be installed but something more appropriate than the old sign as children playing is no longer an issue in this area.
- Email received from a local resident regarding the possibility of renting a common share in the village. Response submitted by the Clerk advising that due to the current situation all discussions regarding the common shares are on hold until such time a parish council meeting can be held.
- Email received from a current common share tenant. Acknowledgement of the email sent to the resident.
- Email response received from NYCC Highways regarding the sign that was once present at the top of the hill at West End.
